
# **Crime Measurements**

The City of McAllen Police Department participates in the Uniform Crime Reporting (UCR) Program. UCR makes possible measurement and analysis of crime index.

### **Crime Index**

Uniform Crime Reporting is the reporting of seven index crimes. The crimes in this group are all serious, either by their nature or because of the frequency of their occurrence. These crimes can be categorized as violent crimes or property crimes. Violent crimes include murder, forcible rape, robbery, and aggravated assault. Property crimes include burglary, larceny-theft, and motor vehicle theft.

# **Crime Trends**

Crime trends are analyzed using two separate methods, crime volume and crime rates.

Crime volume is the collective sum of the seven indexed crimes.

By comparing the volume of indexed crimes from year to year, trends can be evaluated.

Crime rates, on the other hand, are compiled to compensate for the changes in population and show the number of people affected by crime in a given population. Crime rates are usually expressed in the number of crimes per 100,000 residents.

# **Crime Volume**

During the calendar year 2009, there was a total of 8373 index offenses in the City of McAllen. The crime index increase of 1.5 percent when compared to 2008.

# **Crime Rate**


During the calendar year 2009, McAllen's crime rate was 6101.70 crimes per 100,000 persons. The crime rate decreased by 1.15 percent.

The highest month for crime was October with 768 Part 1 crimes reported. The lowest month of reported crime for 2009 was January with 600 Part 1 crimes reported.


**Index Crimes By Month 2009** 



# **Type of Crime**

Crime analysis looks at the two categories of crime mentioned before: Violent crimes (or crimes against persons) and property crimes. In 2009, 4.18 percent of the Crime Index was made up of Violent crime and 95.82 percent was Property crime.


Type of Crime in McAllen 2009




# **Violent Crimes**

Violent Crimes involve the element of personal confrontation between the perpetrator and the victim. Because of their nature, violent crimes are considered to be more serious than property crimes. 350 Violent crimes occurred during 2009, which is a decrease of 5.66 percent from 2008. The Violent crime rate for 2009 was 255.06 crimes per 100,000 residents, which was a decrease of 8.14 percent from 2008.

# Violent Crimes 2000-2009




# Violent Crime by Offense 2009




# **Property Crimes**

The number of property crimes occurring during 2009 was 8023. Property crimes increased by 1.9 percent from 2008. Theft accounted for 85 percent of the property crime, followed by burglary at 10 percent, and then auto theft at 5 percent. The 2009 crime rate was 5846.64 property crimes per 100,000 citizens. This was a decrease of .82% percent when compared to 2008.

Property Crimes 2000-2009




Property Crime by Offense 2009



# **Stolen Property Value**





- There were an estimated 8373 index offenses reported in McAllen in 2009.
- The Crime rate for the City of McAllen was 6101.70 index offenses per 100,000 inhabitants.
- ➤ During 2009, McAllen Police Officers made 8,952\_arrests. Of those arrests, 18 percent were 16 years of age or younger.
- The value of stolen property totaled \$14,437,337.00.
- ➤ Knives were used in 50% of all murders reported.
- ➤ There were an estimated 194 Aggravated assaults. Of these, 35 percent were committed with the use of strong arm tactics.
- > Residential burglaries accounted for 73 percent of all burglaries reported.
- The estimated number of motor vehicle thefts were 441, for a total dollar loss \$7,673,815. Of the types of motor vehicles reported stolen, 59 percent were trucks
- ➤ In 2009, larceny/theft victims suffered losses totaling \$4,340,151.



# **Index Crime Analysis**

# Murder

# **Definition**

Murder and non negligent manslaughter as defined in the UCR program is the willful killing of one human being by another.

This offense category includes any death due to a fight, argument, quarrel, assault or commission of a crime. Attempted murder and assaults with the intent to kill are not counted as murder, but are included in UCR as aggravated assault. Suicides, accidental deaths, and justifiable homicides are also excluded from the murder classification.

The classification of this offense as well as for all Index Crimes is based solely on police investigation and not upon determinations by courts, medical examiners, coroners, juries or other judicial bodies.

# **Analysis**

### Volume


The reported number of murders in McAllen was 4 in 2009. There was a 55.56 percent decrease in the number of murders when compared to 2008. The murders occurred in the months of March, April and July.

### Rate

The murder rate for McAllen in 2009 was 2.91 murders committed for every 100,000 persons. The murder rate decreased by 56.72 percent from 2008.

### Clearance

In 2009, 100% percent of all murders were cleared by arrest or exceptional means.



# **Case Synopsis**

Two murders occurred between 2200 hrs to 2300 hrs, one occurred between 2400 to 0100 hrs and one more occurred between 0100 hrs to 0200 hrs

All four murders occurred inside residences. Two of the murders were committed using knives, one with blunt object and one with a gun. All four of the murders were results of an argument.

Victims included four Hispanic males. The victims ranged in age from 43 to 51 years of age.

All four murders have been cleared by arrest.

# Rape

# **Definition**

Rape, as defined in the Uniform Crime Reporting Program, is the carnal knowledge of a female forcibly and against her will. Statistics reported in this crime category include assaults to commit forcible rape, however, statutory rape (rape against a female under the age of consent) and sexual assaults on males are excluded.

# **Analysis**


### Volume

The number of rapes committed in McAllen in 2009 was 20. This represents an increase of 11.11 percent when compared to 2008. The highest number of Rapes (4) occurred in April.


### Rate

The rape rate for McAllen was 14.57 rapes per 100,000 persons. The rape rate increased by 8.19 percent from 2008.


# Rape 1999-2009

# Rape Offenses by Month 2009




# **Nature of Rape**

Forcible rape differs from other violent crimes because in many cases, the victim is hesitant to report the offense to police. The rigors of court procedures, embarrassment and fear of any accompanying stigma exert a deterrent effect upon the victim's willingness to contact the police. The presence of prior relationship between the victim and offender may make the determination of force difficult to establish, while the usual clandestine nature of this crime presents a problem in verification. As attitudes toward the reporting of rape change, trends in the number of reported offenses can be expected to change correspondingly.

# **Persons Arrested**

Nineteen people arrested for rape in the year 2009. All subjects arrested were males. The age group of 20-24 and 40-44 had the highest number of subjects arrested, followed by the age groups of 45-50.

# **Robbery**

# **Definition**

Robbery, in the Uniform Crime Reporting program, is defined as the taking or attempting to take anything of value from the care, custody, or control of a person or persons by force, threat of force or violence, or by putting the victim in fear.

Robbery is a violent crime that frequently results in injury to the victim. Included in this category are assaults to commit robbery and attempted robberies.

# **Analysis**


### Volume

The number of Robberies committed in McAllen in 2009 was 132. This represents 2.22 percent decrease when compared to 2008. The month of May had the highest number of robberies, and the months of January and August had the lowest number of robberies.

### Rate

The Robbery rate for McAllen in 2009 was 96.19 robberies for every 100,000 persons. The change in the rate of robbery from 2008 was a decrease of 4.79 percent.


# **Reported Robberies by Month 2009**




# **Nature**


In 2009, property loss during the commission of robberies amounted to \$166,044.

Of all reported robberies in 2009, 41 percent were committed using strong arm tactics. Firearms were used in 31 percent of the robberies. Knives/Cutting Instruments were used in 17 percent of the robberies, and other dangerous weapons were used in 11 percent of the robberies.

# **Persons Arrested**

The number of persons arrested for robbery in 2009 totaled 106. The age group representing the largest number of robbery arrestees for the male group was between 20-24 and the female group was 15-19.

# Aggravated Assault

# **Definition**

Aggravated Assault is defined in the Uniform Crime Reporting program as an unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault is usually accompanied by the use of a weapon or by means likely to produce death or great bodily harm. Statistics for aggravated assault include attempts to commit aggravated assault.

# **Analysis**


### Volume

The number of aggravated assaults committed in 2009 were 194. This represents a 7.18 percent decrease from the 209 reported in 2008. More aggravated assaults occurred in June than any other month. January and December had the fewest aggravated assaults.


### Rate


The aggravated assault rate for McAllen in 2009 was 141.37 per 100,000 persons. The rate decreased 9.62 percent from 2008.

# Aggravated Assault by Month 2009





# **Nature**


Of all aggravated assaults, 32 percent were committed with the use of a firearm. Strong arm tactics represented 35 percent. Knives or other cutting instruments were used in 23 percent of the aggravated assaults, and other dangerous weapons were used in the remaining 10 percent. The use or attempted use of a dangerous weapon in an assault or the serious injury inflicted by hands, fists or feet is what separates this index offense from assaults categorized as "simple assaults." Citizens of McAllen reported 1,850 simple assaults in 2009.


# Aggravated Assault as a Percentage of all Violent Crimes



### **Persons Arrested**

McAllen Law Enforcement officers arrested 96 people for aggravated assault in 2009. Of the persons arrested 78 of the perpetrators were male, and 18 were female. The age group with the highest number of aggravated assault arrestees was the age group between 20-24 for males and females.





# Burglary

# **Definition**

Burglary, for Uniform Crime Reporting purposes, is the unlawful entry of a structure with the intent to commit a felony or a theft. While the use of force to gain entry is not required to classify an offense as burglary, attempted forcible entries to commit burglary are counted in this crime's statistics.

# **Analysis**


### Volume

The number of burglaries committed in McAllen in 2009 were 797. This represents a 2.69 percent decrease when compared to the burglaries committed in 2008. More burglaries were committed in December and in July than any other month. The month with the fewest burglaries was February.


### Rate

The 2009 burglary rate was 580.80 burglaries for every 100,000 persons. The change in the burglary rate from 2008 shows a decrease of 5.24 percent.


# Value Lost to Burglary 1999-2009




# **Value**

In 2009, McAllen burglary victims suffered losses totaling \$2,288,059. This total represents an increase of 24.68 percent.



# **Nature**


Of all reported burglaries in 2009, 73 percent occurred at residences. Forcible entry accounted for 69 percent of all burglaries, while 31 percent were unlawful entries without force, and the remainder were forcible entry attempts. Of the offenses for which the time of occurrence was known, 28 percent occurred during the day, and 50 percent occurred during the night.



# **Persons Arrested**

In 2009, 224 people were arrested for burglary. Of the people arrested 203 were male, and 21 were female. The age group with the largest number of burglary arrestees for both males and females was the 15-19 year old age group.

# Larceny/Theft

# **Definition**

Larceny/Theft, in the Uniform
Crime Reporting program, is the
unlawful taking, carrying, leading,
or riding away of property from the
possession or constructive
possession of another.
Larceny/Theft includes crimes
such as shoplifting, pocket-picking,
purse snatching, thefts from motor
vehicles, theft of motor vehicle
parts and accessories, bicycle
thefts, and other things of value in
which no use of force, violence or
fraud occurs.


In the UCR program, this crime classification does not include embezzlement, "con" games, forgery, and the passing of worthless checks. Motor vehicle theft is not included in this category as it is a separate index crime offense.

# **Analysis**

### Volume

The number of thefts committed in McAllen in 2009 was 6785, making this the largest crime category of the Index Crimes. The volume of theft increased 2.82 percent when compared to 2008. More thefts were committed in October than any other month. The fewest thefts occurred in January. It is reasonable to expect that many offenses in this category, particularly where the value of goods stolen is small, are never reported to police agencies.


# Larceny/Theft Offenses 1999-2009



### Rate

The 2009 theft rate for McAllen was 4944.47 thefts per 100,000 persons. The change in theft rate from 2008 was a decrease of 0.12 percent.

# Theft by Month 2009




# **Nature**

In 2009, theft victims suffered losses totaling \$4,340,151. The average dollar loss per theft was \$639.66.


For data collection, larcenytheft is divided into nine pocket-picking, categories: purse-snatching, shoplifting, thefts from motor vehicles, theft of motor vehicle parts, theft of bicycles, theft from buildings, theft from coinoperated machines, and all other thefts (except motor vehicles.) Of the nine theft categories, the highest average theft was the theft from Other's category which vielded an average of \$1,134.09 reported occurrence followed by thefts from autos was \$875.71. Theft of auto parts averaged \$480.99 per report, while theft of bicycles was \$194.72. Coin operated machines had an average of \$179.51 The lowest average per report was from shoplifting with an average at \$145.45

# Larceny/Theft Arrestees by Age and Gender




# **Persons Arrested**

McAllen Law Enforcement officers made 1,705 theft arrests during 2009. Of the subjects arrested for theft during 2009, 808 were female and 897 were male. The age group with the largest number of theft arrestees was the 15-19 year old group with a total of 648 subjects arrested.



### **Nature**


When compared to 2008, the number of shoplifters increased 5.64 percent, while the purse snatching thefts decreased by 28.57 percent. The significant increase is in theft of building which increased 131.92% when compared to 2008.

# Motor Vehicle Theft

# **Definition**

Motor Vehicle Theft, for UCR purposes, is the theft or attempted theft of a motor vehicle. A motor vehicle is defined as a self-propelled vehicle that travels on the surface but not on rails. Specifically excluded from this category are motor boats, construction equipment, airplanes, and farming equipment.

# Motor Vehicle Theft 1999-2009




# **Analysis**

### Volume

The number of motor vehicle thefts committed in McAllen in 2009 was 441. The volume of motor vehicle theft decreased 3.92 percent when compared to 2008. More motor vehicle thefts were committed in February and January than any other month, while the fewest occurred in May and October.

# Motor Vehicle Theft by Month 2009




### Rate

The motor vehicle theft rate for McAllen in 2009 was 321.37 thefts per 100,000 persons. The change in motor vehicle theft decreased by 6.45 percent when compared to 2008.

# Nature

In 2009, motor vehicle theft victims suffered losses totaling \$7,673,815. The average dollar loss per vehicle was \$17,400.94. Of the types of motor vehicles reported to be stolen. 34 percent were autos, 59 percent were trucks, and the remainder (7 percent) are classed as 'other vehicles.' 'other vehicle' classification includes all other motor vehicles included in the UCR definition, such as snowmobiles, motorcycles, motor scooters, trail bikes, mopeds, golf carts, and the like.


# Motor Vehicle Value at Time of Theft 1999-2009






# MVT Arrestees by Age and Gender




# **Motor Vehicle Theft by Type Stolen**




MVT as a Percentage of Property Crime by Volume 2009

# **DWI** Arrests

# **Definition**

For UCR purposes, Driving While Under the Influence (DWI) is the driving or operating any motor vehicle or common carrier while under the influence of liquor or narcotics.


### Volume


As with Part II non-index crimes, information on the number of reported crimes is not collected by the UCR program for this offense. However, the number of persons arrested for this crime is collected.

The number of arrests for DWI in McAllen in 2009 was 844. The volume of arrests decreased 16 percent in comparison to 2008.

### Rate

The 2009 DWI arrest rate was 615.05 per 100,000 persons. When compared to 2008, this was a decrease of 18.31 percent.

# **Nature**

Any consideration of the number and rate of DWI arrests must be reconciled with the fact that many factors control the ability of law enforcement officers to detect drunken drivers. Among the significant factors which drive the DWI arrest rate are these: media coverage of the DWI problem, public awareness, availability of funds for patrol officer overtime, and the skill and training in DWI detection of officers.

# **Persons Arrested**

Of the 844 persons arrested for DWI in 2009, 175 were female and 669 were male. The age group with the highest number of DWI arrestees was the 20-24 year old group.

# **Drug Abuse Arrests**

# **Definition**

For UCR purposes, drug abuse encompasses all violations of the narcotic drug laws. These are offenses such as unlawful possession, sale, use, growing, and manufacturing of narcotic drugs.

In this report, these violations are summarized to include all drug abuse arrests (grand total drug abuse), sale and manufacturing arrests, and drug possession arrests.

As with all Part II non-index crimes, information on the number of reported crimes is not collected for the UCR program. However, the number of persons arrested for these crimes is collected.


# **Arrests**


The reported number of arrests for possession of drugs in McAllen in 2009 was 704. Of the arrestees, 94 were female and 610 were male. The age group with the largest number of persons arrested for drug possession violations was the 25-29 year old group. The largest number of possession arrests came from marijuana at 86 percent, followed by cocaine at 21 percent, and the remaining percentage was comprised of synthetic or other drug types.


For 2009 nineteen arrests were made for the sale and/or manufacturing of narcotics. Those nineteen arrests came from marijuana and cocaine.

# Weapons Arrests

# **Definition**

Weapons: Carrying, possessing includes all violations and attempted violations of regulations or statutes controlling the carrying, using, possessing, furnishing, and manufacturing of deadly weapons or silencers. As with all Part II non-index crimes, the UCR program collects only reports of arrests for this offense.

# **Analysis**


As indicated earlier, Firearms were the murder weapon of choice in 25 percent of McAllen murders.

### **Volume and Rate**


In 2009, 41 arrests for weapon violations were reported. The number of arrests increased 53.66 percent from 2008. The 2009 weapons arrest rate was 29.88 arrests per 100,000 persons. This was an increase of 110.11 percent.

# **Persons Arrested**

Thirty-nine males and two females were arrested for weapons charges. The largest age group of arrestees for weapon violations was the 17-19 and 20-24 year old group.





The City of McAllen is currently authorized 278 sworn officers, and is at 99.02 percent of full strength.


The McAllen Police Department employs 276 full-time sworn officers. The average number of officers per 1000 citizens of McAllen is 2.01 Of the 276 officers, 91 percent are male and 9 percent are female.

### Civilian Personnel


The Police Department is authorized 142 civilian employees.

The McAllen Police Department employs 139 civilian employees, which include Community Service Specialists, Emergency Communications Specialists, Custodians, Records Clerks, Administrative Assistants, Secretaries, Crime Statistician, Animal Wardens, and Fleet Maintenance Personnel. 136 of the civilian employees are non-exempt, and 3 are exempt employees. Of the civilian employees 43 percent are male and 57 percent are female.


# Percentage of Male and Female Sworn Officers

# **APPENDICES**

# Uniform Crime Reporting Offenses

Offenses in Uniform Crime Reporting are divided into two groups designated as Part I and Part II offenses. Offense and arrest information is reported for the Part I offenses, while only arrest information is reported for Part II offenses.

# Part I Offenses

Criminal Homicide – (a) Murder and nonnegligent manslaughter: All willful felonious homicides as distinguished from deaths caused by negligence. Excluded are attempts to kill, assaults, to kill, suicides, accidental deaths and justifiable homicides. Justifiable homicides are limited to: the killing of a person by a law enforcement officer in the line of duty; and the killing of a person in the act of committing a felony by a private citizen; (b) Manslaughter by negligence: any death which the police investigation established primarily was attributable to gross negligence of some individual other than the victim.

Murder and Non-Negligent Manslaughter – The willful (non-negligent) killing of one human being by another. This includes any death due to injuries received in a fight, argument, quarrel, assault, or commission of a crime. Suicides, accidental deaths, assaults to murder, traffic fatalities and attempted murders are not included.

**Justifiable Homicide** – The killing of a person by a law enforcement officer in the line of duty; or the killing (during the commission of a felony) of a felon by a private citizen.

**Manslaughter by Negligence** – The killing of another person through gross negligence.

**Forcible Rape** – The carnal knowledge of a female forcibly and against her will.

**Robbery** – The taking or attempting to take anything of value from the care, custody, or control of a person or persons by force or threat of force or violence and/or by putting the victim in fear.

**Aggravated Assault** – An unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault is usually accompanied by the use of a weapon or by means likely to produce death or great bodily harm.

**Burglary** – The unlawful entry of a structure to commit a felony or theft. This includes breaking and entering with intent to commit a larceny; housebreaking; safe cracking; and all attempts at these offenses.

Larceny-Theft — The unlawful taking, carrying, leading, or riding away of property from the possession or constructive possession of another. This includes pocket-picking, purse-snatching, shoplifting, theft from motor vehicles, theft of motor vehicle parts and accessories, theft of bicycles, theft from buildings, theft from coin-operated machines, and all thefts that don't fit into the above mentioned categories.

**Motor Vehicle Theft** – The theft or attempted theft of a motor vehicle, which is defined as a self-propelled vehicle that runs on land surface and not on rails.

# GLOSSARY OF TERMS

**Adult** – In Texas, an adult is a person 17 years of age or over. National law provides that adults are age 18 or over. Unless otherwise indicated, this publication follows the state definition.

Cleared by Arrest or Exceptional Means -For Uniform Crime Reporting purposes, an offense is cleared by arrest or solved when at least one person is arrested, charged with the commission of an offense and turned over to In certain situations, court for prosecution. police are not able to follow these three steps and, if the following four conditions can be met, the offense can be cleared exceptionally: (1) the investigation has definitely established the identity of the offender; (2) there is enough information to support an arrest, charge, and turning over to the court for prosecution; (3) the exact location of the offender is known so that he could be taken into custody; (4) there is some reason outside the police control that prevents the arresting, charging, and prosecuting of the offender.

Crime Index — The sum of seven index offenses used to measure the extent, fluctuation and distribution of a crime in a given geographical area. Crime classifications used in the Crime Index are: murder, rape, robbery, aggravated assault, burglary, larceny-theft and motor vehicle theft. While arson is also an index offense, it is not part of the Crime Index.

**Crime Rate** – The number of offenses per 100,000 inhabitants. To calculate a crime rate, divide the population by 100,000 and then divide the number of offenses by that answer. The crime rate is useful in determining the relative frequency of crime without regard to fluctuations in population.

**Index Crime** – A crime for which reports of offenses committed are collected. Index crimes are murder, rape, robbery, aggravated assault, burglary, larceny-theft, motor vehicle theft and arson.

**Juvenile** – In Texas, a juvenile is a person 16 years of age or under.

**Non-Violent Crime** – Property crimes; the index offenses of burglary, larceny-theft and motor vehicle theft.

**Personal Weapon** – The use of hands, feet, fists and teeth as a weapon to commit a crime; also termed strong-arm weapon.

**Strong-Arm Weapons** – The use of hands, feet, fists and teeth as a weapon to commit a crime. Also termed personal weapon.

**Threat** – A declared intent to inflict bodily harm on a person.

**Violent Crime** – Consists of the Index Offenses of murder, forcible rape, robbery and aggravated assault. Also referred to as crimes against persons.
