What Is Ethics?

- Ethics... from the Greek "Ethos"
 - The disposition, *character*, or fundamental values peculiar to a specific person, people, culture, or movement
- It's about <u>choices</u> and our <u>use of discretion</u>
- Applying the appropriate public service <u>values</u> to achieve the right <u>outcome</u> in the right <u>way</u>



Why are ethics important?

- It defines who we are
- Character is important
- Foundation for good leadership
- Organizational culture
- Keeps us grounded
- We serve the public trust
