Ms. Ramirez is leading the municipality of Brownsville and its workforce of more than 1,200 employees under a ONE CITY philosophy, in which the organization is creating partnerships and collaborations with external agencies to realize Brownsville to its fullest potential. She continues to strengthen the City's economy, creating employment opportunities for its intergenerational workforce, building upon a Strategic Vision that values Quality of Life, and creating a legacy for generations to come.
