

### Comparison with Prior Month

Net income before depreciation, as reflected on page 3, for the month of June is \$131,466. This does not include depreciation expense of \$122,088 and the debt transfer in for Series B of \$70,165. Net income before depreciation was \$14,092 more than the prior month. Toll Revenues for the month were \$168,627. Toll revenues were \$14,463 more than prior month. Expenses were \$44,016 or \$1,336 more than prior month.

### Comparison with Budget

Net income before depreciation, as reflected on page 4, for the month of June is \$131,466. Net income before depreciation was (\$42,860) less than budget for the month. Toll revenues were \$168,627 for the month. Toll revenues were (\$83,126) less than budget for the month. June's monthly expenses were \$44,016 or (\$44,016) less than budget for the month.
