

Through the Housing and Community Development Act of 1974, the City of McAllen is eligible for funds from the U.S. Department of Housing and Urban Development (HUD). A wide range of programs and projects dealing with neighborhood improvements and city services may be implemented through this federally assisted program called Community Development Block Grant (CDBG).

Since program inception, the City of McAllen has received more than \$90 Million in CDBG funds. These funds are used to improve and enhance the quality of life for the citizens of McAllen, with primary emphasis on low and moderate-income persons residing in targeted areas of the City.

All funded activities must meet at least one of three national objectives: elimination of slum or blight and/or benefit of low-income families or persons and/or be of urgent need.

To further encourage public participation, the City Commission has appointed a panel of 14 citizens who comprise the Community Development Advisory Committee (CDAC). The CDAC serves to review funding applications for purpose of proposing activities to the City Commission. The City Commission holds a final public hearing to consider the CDAC recommendations and subsequently approve the CDBG application.
