Notice of Proposed Substantial Amendment to the FY 2024 Annual Action Plan  
COMMENT PERIOD: February 10, 2026 through March 13, 2026

Notice is hereby given that the City of McAllen, through the Grant Administration Department is proposing a Substantial Amendment to the PY 2024-2025 Annual Action Plan. The City is an Entitlement City in the U.S. Department of Housing and Urban Development's (HUD) Emergency Solutions Grant.

Public Notice and Public Hearings are required for Substantial Amendments to the City's Annual Action Plan. As per the City's Citizen Participation Plan (CPP) and 24 CFR Part 91, the City will amend its approved plan(s) whenever it makes one of the following decisions:

1. To make a change in the goal, priority, or activity of the Consolidated Plan; or
2. To carry out an activity, using funds from any program covered by the Consolidated Plan " (including program income), not previously covered in the Action Plan; or
3. To change the purpose, scope, location, or beneficiaries of an activity included in the annual action plan.

Proposed Budget Amendment FY 2024-2025:

1. **Cancel: Catholic Charities of Rio Grande Valley - Homeless Prevention-** The City is proposing to cancel the activity since the agency relinquished their funding.
2. **Cancel: Catholic Charities of Rio Grande Vally - HMIS** - The City is proposing to cancel the activity since the agency relinquished their funding.
3. **Create: Endeavors – Homeless Prevention** - The City is proposing to reprogram funds to Endeavors to provide supporting services and rental assistance to families experiencing housing instability.
4. **Create: Endeavors – Rapid Rehousing** - The City is proposing to reprogram funds to Endeavors to provide supporting services and rental assistance to families experiencing homelessness.
