Before me, the undersigned authority, on this day personally appeared (name) Antonio Aquille Jr., who being by me here and now duly sworn, upon oath says:

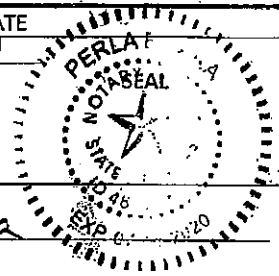
