### Law enforcement initiative nets multiple arrests

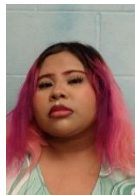
McAllen Police Department officers conducted a law enforcement initiative that resulted in the arrest of six individuals involved in prostitution-related offenses.

- On November 12, 2025, officers arrested one female for the offense of Prostitution.
- On November 13, 2025, officers arrested one male for Prostitution and another male for Solicitation of Prostitution.
- On November 14, 2025, three additional males were arrested—one for Prostitution and two for Solicitation of Prostitution—in connection with the ongoing initiative.
