STREET LIGHTS	The cost of the electric bill for the street lights is paid by the City of McAllen from city property taxes. The spacing of street lights is every 250 feet.	Before subdivision recording you will be charged \$180.00 or more per required street light to cover the subdivision's electric bill for the first year. After one year of recording your subdivision or sooner, the Hidalgo County Tax Assessor/collector will charge each lot owner a street light fee in their property tax statement to cover the street light electricity fee. The new county standards require a street light every 250 feet.
AMBULANCE	The City of McAllen has a contract with Medcare, Inc. for ambulance services. As per the contract the company is required to have eight (8) ambulances within the city limits at all times.	The county provides services through contracts with various providers. No ambulances on stand by like in McAllen.
POLICE	The McAllen Police Department constantly provides quality community-oriented services to enhance public safety. The department strives to have 2.0 officers per 1,000 population ratio at all times. This ratio is the highest in South Texas and among the highest in Texas.	The Hidalgo County Sheriff Department's mission is to provide a sense of security for the public. Based on the estimated population they serve and the number of officers that conduct patrolling their ratio is 0.4 officers per 1,000 in population.
FIRE	The McAllen Fire Department has 176 paid firefighters and 17 civilian staff. The department provides excellent quality of service to the citizens of McAllen.	The county does not have a Fire Department. Services are with contracts with various city fire departments.
ISO INSURANCE RATES	McAllen's Insurance Service Office(ISO) Rating is a # 2. South of the City of San Antonio the only cities to have an ISO rating this low are McAllen and Corpus Christi. A low ISO number gives your future lot owners low property insurance premiums.	The county does not have ISO ratings. Insurance premiums for new houses in the county could be more expensive.
CODE	The City of McAllen has a Code Compliance Department composed of 19 code enforcement officers. The city is divided into code compliance zones and every neighborhood has regular code compliance inspections. Parking in the front yard is prohibited.	Code enforcement conducted by Hidalgo County covers the areas in the county not inside the city limits of a municipal government with five (5) code enforcement officers. The officers primarily handles issues related to weedy lots and illegal dumping. Parking in the front yard is allowed.
ANIMAL CONTROL	The animal control division of the McAllen Police Department is made up of six (6) animal control officers to serve the community.	Hidalgo County covers the areas in the county not inside the city limits of a municipal government with seven (7) animal control officers.
MOSQUITO SPRAYING	Mosquito spraying takes place year round. Traps are placed throughout the city. Based on the results of the traps mosquito spraying, prevention and education to the residents takes place	No such services in the county. The county only conducts mosquito spraying after large rains.
STREET SWEEPING	Occurs quarterly weather permitting.	No such services in the county.
GARBAGE COLLECTION	Each resident receives a trash bin for the garbage and one for the recyclable materials. Each bin is picked up once a week at an affordable rate.	No such services in the county. Residents must contract with a private garbage collection company or haul their garbage to a county transfer station.
BRUSH COLLECTION	Brush is collected at every residence inside the city limits once per month at an affordable rate.	No such services in the county.
