

NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.448989 per \$100 valuation has been proposed by the governing body of City of McAllen.

PROPOSED TAX RATE	\$0.448989 per \$100
NO-NEW-REVENUE TAX RATE	\$0.444778 per \$100
VOTER-APPROVAL TAX RATE	\$0.517054 per \$100

The no-new-revenue tax rate is the tax rate for the 2026 tax year that will raise the same amount of property tax revenue for City of McAllen from the same properties in both the 2025 tax year and the 2026 tax year.

The voter-approval rate is the highest tax rate that City of McAllen may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that City of McAllen is proposing to increase property taxes for the 2026 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 28, 2026 AT 5:00 PM AT McAllen City Hall, 3rd Floor, 1300 Houston Avenue, McAllen TX 78501.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, City of McAllen is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the City of McAllen at their offices or by attending the public hearing mentioned above.
